by using the same and all threshers' liens and rights to liens therefor which may accrue, with full power to exercise the same in the name of the Pur-
chaser or any such other person.

In the event of the said machinery being seized for payment of taxes, the Vendor may pay such taxes, together with any costs in connection
with such seizure, and all such moneys shall be forthwith repayable by the Purchaser to the Vendor with interest at the contract rate from the date
on which the Vendor paid same, and any moneys so paid by the Vendor shall be added to and form a part of the purchase money of the said machinery.
