AGREEMENT

BETWEEN BOARD AND TEACHER (FOR SCHOOLS ORGANIZED UNDER THE SCHOOL ACT)

This Memorandum of Agreement between the Board of Trustees of the Clear Ridge Name of district
School District No. 3944, of Saskatchewan, hereinafter called "The Board"
and Gudrun H. Instad hereinafter called "The Teacher," holder
Name in full of teacher

of a valid Saskatchewan certificate of qualification to teach in such school, is made pursuant to a resolution
passed by the Board at a meeting held on the 16 day of Feb
Date Month

194....., in accordance with the provisions of *The School Act* and in particular, Sections 109, 110, 111 and
212 thereof, and provides as follows:

1. The Board hereby contracts with and employs the teacher from and after the 19 day
of Feb, one thousand nine hundred and forty-5, at the yearly salary
of one thousand dollars dollars, to be computed
and paid in accordance with the provisions of *The School Act* and further agrees that it and its successors
in office will exercise such powers and perform such duties under *The School Act* and the Regulations of
the Department of Education as may be requisite for the payment of such salary.

2. The Teacher agrees with the Board to teach and conduct the school according to *The School Act*
and the Regulations in that behalf.

3. This agreement is subject to the condition that the teacher shall continue to be the holder of a valid
certificate of qualification as a teacher in Saskatchewan.

4. The Board hereby agrees to increase the salary of the teacher by the sum of
dollars each year until a maximum of dollars per annum is reached.

5. This agreement shall continue in force until terminated in accordance with the provisions of *The
School Act*, or replaced by a new agreement.

6. The vacation periods shall consist of: Summer vacation (Dates);

Winter vacation (Dates); Easter vacation (Dates)

teacher before the teacher enters upon his duties or within seven days thereafter.
