AGREEMENT

BETWEEN BOARD AND TEACHER

(FOR SCHOOLS ORGANIZED UNDER THE SCHOOL ACT AND THE LARGER SCHOOL UNITS ACT)

This Memorandum of Agreement between the Board of the Outlook Name of Unit

School Unit No. 32, of Saskatchewan, hereinafter called "The Board"

and Gudrun Tasted Name in full of teacher hereinafter called "The Teacher," holder

of a valid Saskatchewan certificate of qualification to teach in such school, is made pursuant to a resolution

passed by the Board at a meeting held on the 20th Date day of November Month

1947, in accordance with the provisions of *The School Act* and *The Larger School Units Act* and provides as follows:

1. The Board hereby contracts with and employs the teacher from and after the 20th day of January, one thousand nine hundred and forty-eight, at the yearly salary of TWELVE HUNDRED (\$1200.00) dollars, to be computed and paid in accordance with the provisions of *The Larger School Units Act* and *The School Act* and further agrees that it and its successors in office will exercise such powers and perform such duties under *The Larger School Units Act*, *The School Act* and the Regulations of the Department of Education as may be requisite for the payment of such salary.

2. The Teacher agrees with the Board to teach and conduct the school according to *The School Act* and the Regulations in that behalf.

3. This agreement is subject to the condition that the teacher shall continue to be the holder of a valid certificate of qualification as a teacher in Saskatchewan.

4. The Board hereby agrees to increase the salary of the teacher by the sum of Fifty (\$50.00) dollars ~~each year until a maximum of x as per schedule~~ dollars per annum is reached.

5. This agreement shall continue in force until terminated in accordance with the provisions of *The School Act*, or replaced by a new agreement.

6. The vacation periods shall consist of: Summer vacation July 1st to Sept. 1st (Dates); Winter vacation Dec. 19th to Jan. 20th (Dates); Easter vacation Good Friday & Easter Monday (Dates)

- Note.—1. The teacher must sign this agreement with christian names in full and give the number as on certificate held.
2. Except with the consent of the Minister, the minimum salary shall be at least \$1,200 per annum for teachers with permanent certificates and at least \$1,000 per annum for all other teachers.
3. This agreement will not be accepted by the department unless complete in every detail.
4. Section 127 of *The School Act* requires the agreement to be completed by the board and the teacher before the teacher enters upon his duties or within seven days thereafter.
