



8. This form must remain in your hand for a 24 hour period to allow you to make a studied decision.

9. You must return this form duly completed and signed to the Officer designated to receive it by your Commanding Officer.

10. The policy regarding tours of duty in the Pacific Theatre and the European Theatre have not yet been announced. It is probable, however, that tours may be somewhat along the following lines.

PACIFIC THEATRE - AIRCREW - 35 Operational Trips or 18 months whichever is the shorter.

GROUNDCREW- 18 months to 2 years.

EUROPEAN THEATRE - AIRCREW- 18 months.

GROUNDCREW) 18 months to 2 years.

11. All personnel declaring they wish to serve in the Pacific Theatre or the European Occupation Force will be granted 30 days leave in Canada. For the Pacific Theatre this leave will be granted as soon as circumstances permit after arrival in Canada, and prior to proceeding to the Pacific. For the European Theatre the leave will be arranged as shipping space becomes available and as expeditiously as possible.

12. There are certain continuing benefits available for those who are serving outside Canada. These are :-

- (a) Continuation of exemption from Income Tax.
- (b) Continuation of all post-discharge benefits under the War Service Grants Act, 1944, i.e. War Service Gratuities, Re-Establishment Credits.
