



IN THE SUPREME COURT OF ONTARIO.

THIS IS TO CERTIFY that by a Judgment bearing date 16th day of May, 1919, and made by the Honourable Mr. Justice Sutherland, in a certain Matter pending therein, that is to say:-

In the Matter of the Estate of Duncan Rowan, late of the City of Vancouver in the Province of British Columbia, Canneryman, deceased,

Archibald S. Stirrett and John R. Ross, Executors of the last Will and Testament of said Duncan Rowan, deceased,
Applicants,

Angus Rowan, Mary Ann Rowan, John Rowan, Catharine McArthur, Elizabeth Rowan, Sarah Ribble, Alexander Rowan, Jessie Rowan, Mary Miller Rowan, Duncan Rowan, Pauline Rowan; and Alice Rowan, the last two named being infants under the age of twenty one years, Respondents.

Upon motion made unto the said Court on behalf of the said Applicant on the 2nd day of April, 1919, for an Order construing the Will of the said late Duncan Rowan;

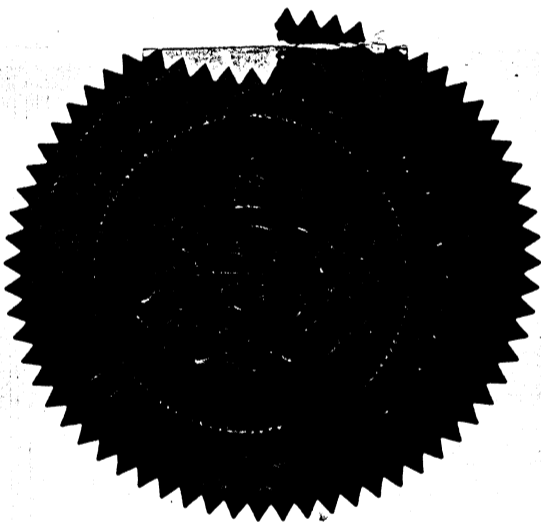
THE SAID COURT DID DECLARE (inter alia) that under the devise to said Executors and Trustees in trust for Duncan Rowan, nephew of the said Testator of a one half undivided interest in and to that portion of land situate in Township of Kincardine, County of Bruce and Province of Ontario containing one hundred and forty acres and being incorrectly described as Park lot "A" subdivision of lots twenty two (22) twenty three (23) and twenty four (24) Concession "A" Lake Range Township of Kincardine, Bruce County, Province of Ontario, and also part of lots twenty two (22) twenty three (23) and twenty four (24) Concession "A" Lake Range in said Township of Kincardine and Province of Ontario contained in the Will of said Duncan Rowan, deceased, there was intended to be devised the undivided one half interest owned by said Duncan Rowan

deceased in Park lot ~~B~~ "A" in the subdivision of lots numbers thirty two, thirty three and thirty four in Concession "A" Lake Range of said Township of Kincardine in the County of Bruce aforesaid, and the parts of lots thirty two, thirty three and thirty four in said Concession "A"^{as} described in the conveyance thereof from Duncan Rowan to Duncan Rowan~~s~~ dated the 8th day of February 1899 and registered in the Registry Office for the County of Bruce as number 8614 for the said Township of Kincardine which passed to the said Applicants upon the trusts in said Will mentioned and contained and ~~did~~ order and adjudge the same accordingly.

AND THE SAID COURT DID FURTHER ORDER AND ADJUDGE that the said Applicant should convey said lands so intended to be devised to said Duncan Rowan as directed by said Will.

And at the request of said Executors this certificate is given for the purpose of registration pursuant to the statute in that behalf.
