Posted #422 Squadron March 28th, 1943

Rank J/CPL April 1st, 1943

Completed training as a "Armourer (B) A" April 1st, 1943

Hospitalized with severe rash on face (Sycosis Barbae) and was off duty from April 11th, 1943 to April 20th, 1943 Discharged with 48 hour pass.

Leave granted May 28th, 1943 to June 14th, 1943 (18 days)

Confined to base for 3 days June 16, 1943 for returning from leave 19 hours 4 minutes late (Bowmore Scotland)

Leave granted September 3rd, 1943 to September 13th, 1943 (11 days)

Applied September 26th, 1943 stationed in Bowmore, Scotland, to train as an air pilot
Reason given: To fight more actively in war

Posted #8422 SE Squadron Echelon October 15th, 1943

Applied on November 17th to enlist for air crew duties.

Recommended November 18th, 1943 to train as P.N.B.

Training @ A.C.S.B. Edinburgh November 18th, 1943

Takes Medical November 26th, 1943 address is Port Ellen, (15 Group) near Bowmore, Scotland.
